# Keeping the bad guys away since April 1999

Preventing resident abuse, thievery, and violence in the workplace has always been of supreme importance to every responsible nursing home and health care administrator. Finding a cost effective and efficient way to get a base level of comfort that the perspective employee has the character and competence that is suitable for your facility and operation has always been a challenge. References that verify "dates of employment only" or those that are not returned at all are a level of checking that health care professions can no longer be comfortable with.

Monroe County, New York, and Rochester-area long-term care and other health care providers have joined forces to institute a program for screening out potentially abusive and possibly dishonest prospective employees through voluntary criminal background checks.

Similar programs have run thousands of checks on the identical platform at the request of the participating nursing homes. These checks revealed that approximately one-third of all job applicants had criminal records—either misdemeanors or felonies; many of which involved serious offenses, such as sexual assault, manslaughter, rape, child endangerment, and drug and weapons charges.

## What if we are already doing FBI checks....

Skilled nursing facilities are mandated to perform FBI criminal background checks through the New York State Department of Health. These checks are run retrospectively on all new hires who come in contact with residents during the course of their assigned duties and do not have professional licenses. The cost of the checks are roughly ninety five dollars, not including staff time to take the actual finger prints of the applicant and file the necessary paperwork.



It can take up to 6 months, and in some cases longer, to receive the results of the finger printing. The results of the finger printing may mandate that you terminate employment of the individual should the check reveal convictions.

With the Monroe County Criminal Background check, the employer can find out if the applicant has convictions anywhere within Monroe County, usually within five days, before the employment offer is made.

These checks are done at a level that is not offered by other services that run internet or public records checks. According to the Sheriff's office there are two major data bases in the county, the city of Rochester data base and the County Sheriff's data base that includes data from all of the towns. Both are checked through this program.
